This is the Privacy Policy for the ReVive Center for Housing and Healing (ReVive) website. We value your privacy. This Privacy Policy provides information about our collection and use of certain information obtained via this website.

Before utilizing this website, please read all of this Privacy Policy. By accessing any areas of this website, you agree to be legally bound and to abide by the terms and conditions of this Privacy Policy. If you do not agree with the terms of this Privacy Policy do not use this website and do not provide us with any information about you.

References to "we," "us" and "our" refers to the ReVive. References to "you" and "your" refers to the user of this website. Information that identifies you, such as a combination of your full name, address and phone number is referred to as "personally identifiable information."

### **A Special Note About Children**

This website is not designed or intended for use by children under 13 years of age. If you are under 18 years of age, you should use this website only with the involvement of a parent or guardian. Children under 13 years of age may not submit any personally identifiable information to us. If we discover that we have inadvertently gathered any such information from a child under 13 years of age, we will take steps to delete it.

### **How Information is Collected**

The only personally identifiable information we collect on this site is voluntarily provided to us by individuals who request an eNewsletter, communicate with us by e-mail or ask us to send an eCard or e-mail a webpage. If you donate to us online, your personally identifiable information is collected by ReVive and maintained in our donor database. Your credit number is not retained by ReVive or by its credit card processor, Blackbaud Merchant Services.

### **How Information is Shared**

We do not rent or sell personally identifiable information we collect on this website to other individuals or organizations. From time to time, we may share certain information with other organizations we are affiliated with or with companies and/or individuals employed to perform various functions on our behalf. We may also disclose information (i) to protect against or investigate fraud or other potentially harmful or illegal activities; (ii) if required by law; and/or (iii) to establish or exercise our legal rights or defend claims.

### **How Information is Used**

We primarily use information collected via this website to provide items you request, to process donations and to answer questions. We may also use this information to send you communications, such as our quarterly eNewsletters, or information about special

events or support opportunities. If you request that we send an eCard or e-mail a webpage, the recipient will not be placed on a distribution list to receive further communications but will only receive the eCard or the e-mailed page.

### **Your Choices**

If you receive e-mail communications from us that you no longer wish to receive, you can request that we remove you from our distribution list by clicking on the unsubscribe link in the e-mail. You may also write or call us at the address or phone number below.

### **How Information is Protected**

Safeguarding personally identifiable information is of prime importance to us. Network for Good uses SSL encryption to help protect sensitive personal information. When you donate to us online, you will know you are on a secure page because the web address will begin with "https" instead of the more common "http." The browser window will also display a lock icon, which you can click on for further information. While no system is completely foolproof, we take security very seriously and have security measures designed to protect information in a responsible manner.
